



CALL FOR APPLICATIONS

PhD CREDIT-SEEKING SCHOLARSHIPS (6-MONTH RESEARCH MOBILITY)

⇒ **RAMDDA Project** – Drug Design and Discovery

The RAMDDA Project (Research and Academic Mobility for Drug Design and Discovery in Africa) invites applications for **five (5) PhD credit-seeking research scholarships** to support short-term research mobility in advanced areas of drug design and discovery.

These scholarships aim to strengthen doctoral research capacity, promote inter-institutional collaboration, and enhance advanced training in experimental and computational chemistry across Africa.

⇒ **Host Institutions (One Scholarship per Institution)**

- 1) **University of Botswana** (UB) – Botswana
- 2) **Botswana International University of Science and Technology** (BIUST) – Botswana
- 3) **Addis Ababa University** (AAU) – Ethiopia
- 4) **Adama Science and Technology University** (ASTU) – Ethiopia
- 5) **University of Ghana** (UG) – Ghana

⇒ **Scholarship Duration**

- Six (6) months per scholarship
- Credit-seeking (research stay contributing to the applicant's PhD degree at their home institution)

⇒ **Eligible Research Areas**

Applicants must propose research strictly aligned with drug design and discovery within one of the following disciplines:

- 1) Organic Chemistry
 - Natural Product Chemistry
 - Synthesis
 - Materials Chemistry
- 2) Physical Chemistry
- 3) Computational Chemistry
- 4) Materials Science or related
- 5) Bioinorganic Chemistry

Interdisciplinary proposals are welcome only if clearly focused on drug discovery applications.



⇒ Eligibility Criteria

Applicants must:

1. Be African nationals and residents of an African country,
2. Be currently registered PhD students in Chemistry or a closely related field at their home university in Africa,
3. Be conducting research relevant to drug design and discovery, and drug delivery,
4. Demonstrate that the proposed research will contribute to their PhD thesis,
5. Be able to undertake a full-time, six-month research stay at the host institution,
6. Obtain formal endorsement from:
 - Your PhD supervisor (s) at the home institution
 - The proposed host supervisor (s) at host institution (*however, please note that the Consortium Board will consider the proposed supervisor (s) at the host but can also assign different supervisor(s) with proper skill and experiences in PhD supervision*).

⇒ Required Application Documents

A complete application must include:

- ☐ Completed RAMDDA Scholarship Application Form (see the Downloads page)
- ☐ Copy of Passport (only biodata pages)
- ☐ Research Proposal prepared strictly using the RAMDDA Proposal Template
- ☐ Curriculum Vitae (max. 4 pages)
- ☐ Proof of PhD registration from the home university
- ☐ Academic transcripts (Master's and PhD, where available)
- ☐ Motivation letter (max. 1 page)
- ☐ Letter of support from the home supervisor(s)
- ☐ Proof of Residence (National ID)
- ☐ Language Test Results (if available)
- ☐ Certificate of Work Experience (if available)
- ☐ List of Publications and conference presentations (If there are any)
- ☐ Proof of belonging to disadvantaged group (if applicable)
- ☐ All other documents you consider useful to evaluate your profile

⇒ Selection Criteria

Applications will be evaluated based on:

- Scientific quality and feasibility of the proposed research
- Relevance to drug design and discovery
- Alignment with RAMDDA research objectives
- Applicant's academic background and research potential



- Expected contribution to capacity building and collaboration

- Be African nationals and residents of an African country

As per the funder's requirements, applicants are not eligible for the scholarships from the country of their origin (e.g. Ethiopian nationals are not eligible to apply for AAU and ASTU scholarships). Applications from female candidates and under-represented groups are strongly encouraged in line with EU gender equality and inclusion policies.

⇒ **Financial Support**

Each scholarship will provide financial support in accordance with RAMDDA mobility rules, covering eligible costs related to the six-month research stay (details will be communicated to successful candidates).

⇒ **Application Submission**

Application deadline: March 15, 2026

Notification of results: on or before March 31, 2026
